# **INKPEN PARISH COUNCIL**

**2. Minutes of the previous meeting** – the draft minutes of the meeting held on 21<sup>st</sup> June 2022 were approved as a true record and had been displayed on the Parish website. There was one issue arising that of speeding in the village and that was discussed as documented below.

## **3. Declaration of Interest:**

3.1 Councillors are the Corporate and Custodian Trustees of the Inkpen Memorial Playing Field – and as such declared 'personal interest' in item 7 for Grants made under Section 137.

3.2 The following declaration is made on all minutes for clarification for residents.

Inkpen Parish Council is the Corporate & Custodian Trustee of the Memorial Playing Field Trust and registered with the Charity Commission as the Corporate and Custodian Trustee. Trust meetings and funds are held separately as required by the Charity Commission and confirmed annually to the External Auditors.

As confirmed by the Charity Commission: "The Charity is simply managed and administered by the Council and is not a public sector organisation and not subject to the Freedom of Information Act." All information about the Charity can be viewed on the Charity Commission website.

## 4. Matters Arising:

## 4.1 a) Speeding in Inkpen

The issue of speeding in Inkpen was discussed. J. Cole provided details of options available and a paper he had written regarding speeding in the area. Mr Bates agreed to contact Cheryl Evans of West Berkshire Council (<u>Cheryl.evans@westberks.gov.uk</u>) to discuss the possibility of Inkpen borrowing a SID and discuss any other options available to reduce speeding. # 5. Policy/Plan to cope with Summer Fires

The concerns about the potential of serious fires as a result of the hot weather were discussed and the awareness regarding contingencies in place by residents. It was agreed that D Thomas would contact the Fire Brigade to discuss the best approach. J Cole to contact Carolyn Richardson to understand West Berkshire Council's advice to parishes.

It was agreed that the pavilion should be made available to residents where a local emergency occurs, such as loss of electricity or water supply problems. It would be used as a contact point and usage would be granted on a case-by-case basis. The costs would be covered by Inkpen Parish Council

D Thomas advised that there would be two geophysics surveys taking place in the village this year, starting on 18<sup>th</sup> August and this was part of the conservation appraisal. Other sites in Inkpen would be surveyed in 2023.
